Introduction – RCPI Trainee Courses

This prospectus details the courses available for trainees in all registered training programmes within RCPI - Basic Specialist Training, Registrar Training Programme, and Higher Specialist Training. The mandatory courses are outlined individually and other professional development courses are also listed.

Under each course you will find the learning objectives, learning methods, and course content. Venues, dates and times are also outlined. Please note these are subject to change.

We have introduced online education as part of training and you can access the online courses via Moodle on the private website. To access your online courses:

- Login to private website using your RCPI username and password
- On the services page click on the link or Moodle
- Enter your RCPI username and password on the Moodle login page
- Your username is the beginning of your @physicians email address before the @ symbol. For example, if your email address is moodlestudent@physicians.ie, your username is moodlestudent.
- Your password is the same password used to access the RCPI private website.
- You will be automatically enrolled on all of your mandatory online courses.

To access application forms for all courses please log into the private website and click on courses. Application forms can then be faxed or posted into the College. Each course is filled on a first come first serve basis.

Please be advised that if cancellations are not received within ten working days of the course start date, there will be a charge of €150.00 to attend the next course. This also applies to no-shows. All mandatory courses must be completed within the training period on the relative training scheme. You will not receive certification of completion until you have completed all of your mandatory courses.

Confirmation of your application and any further correspondence relating to the course will be sent to your physicians email address only. No other email is acceptable.

The Royal College of Physicians of Ireland: An Introduction

Mission

The mission of the Royal College of Physicians of Ireland is to develop and maintain high professional standards in specialist medical practice in order to achieve optimum patient care and to promote health nationally and internationally.

About the College

The Royal College of Physicians of Ireland, through its six accredited training bodies, is the largest postgraduate medical education and training institution in Ireland and, since 1654, has been responsible for maintaining standards in medical practice.

It is a not-for-profit body with a mission to promote and maintain the highest quality of speciality medical care, to build positive relationships between the medical profession and the public and to lead and influence policy on health and the future direction of the medical profession.

Governance

The President and Fellows are the governors of RCPI and are ultimately responsible for its affairs. Currently over 1,600 physicians are Fellows of the RCPI most of whom are involved in RCPI activities. On an annual basis, however, the Fellows delegate their responsibility for RCPI affairs to Council.

Council consists of 31 Fellows – including the President, Registrar, Treasurer and Chief Executive Officer. Council is responsible for managing RCPI affairs on behalf of the Fellowship and is also responsible for the strategic development and future direction of RCPI. Members of Council are elected by the Fellowship on an annual basis, at the Annual Stated Meeting, and are representative of the RCPI's broad medical specialties and interests. Council meets on a quarterly basis and reports on its activity to the President and Fellows. Council is advised by a robust physician-led committee infrastructure supported by an administrative centre of over 50 staff.

The Executive implements the strategic developments recommended by Council and monitors the day-to-day business of the RCPI. The Executive consists of the President, Registrar, Treasurer and Chief Executive Officer.

The Deanery, with support of the standing and other committees, are responsible for the provision of examinations, education and training services.

The Standing Committees advise the Deanery, Executive and Council on policies, procedures and developments relating to examination, education, training and other activities.

The Royal College of Physicians of Ireland: History of the College

The Royal College of Physicians of Ireland was founded in 1654 by John Stearne, a physician and Professor of Trinity College, as a Fraternity of Physicians, in response to his recognition of the need for an improvement in the medical services available to the people of Ireland. Trinity College provided a building where the Fraternity of Physicians could meet and study.

A Royal Charter was obtained from Charles II in 1667 and this gave the College the power to examine doctors and award licences to those deemed fit to practice, within a seven mile radius of Dublin.

Twenty five years later under the Presidency of Sir Patrick Dun, a second Royal Charter was obtained in 1692 from the joint sovereigns, King William and Queen Mary. This Charter, which is still in force today, severed the link with Trinity. The College's licensing powers were extended to cover the whole of Ireland.

Sir Patrick Dun died in 1713 and bequeathed all his property, including extensive land holdings in Co. Waterford, to the College. Dun's estate was to provide considerable funds to the College for the next 200 years.

Having left the premises provided by Trinity College, the Physicians had no permanent home until 1815 when Sir Patrick Dun's Hospital opened. This had been built by the College as a teaching hospital from the proceeds of Dun's bequest and the College moved into rooms in the Hospital building.

By the middle of the 19th century, Irish medicine was enjoying great international prestige through the work of great doctors such as Robert Graves, William Stokes, John Cheyne and Dominic Corrigan. The Fellows of the College decided that they needed a new college hall, near the centre of the city that would reflect their new-found glory.

In 1860, the College purchased the property of the Kildare Street Club for £5,000. Shortly after the purchase was completed, however, the building was completely destroyed in a disastrous fire, which cost the lives of three of the Club servants.

The College was able to recover the money spent through the insurance settlement and was then able to have a new building designed to its own specifications.

A competition for architects was held and the winning design was that of William Murray Jnr, whose father, William Murray Snr, had designed the new Royal College of Surgeons building on St. Stephen's Green. The building was completed in 1864 and has been the College's home ever since. The building has undergone much restoration and refurbishment in more recent years and is now fully equipped with modern conference, meeting and communication facilities, but it is pleasing to note that the original structure has been largely unchanged and the main rooms upstairs still stand much as they would have looked in 1864.

Today, having been instrumental in establishing renowned teaching hospitals, collaborating with medical schools and advancing medical science, the College is now primarily concerned with postgraduate medical education and the maintenance of high standards in medicine.

Basic Specialist Training

Basic Specialist Training (BST) provides doctors with the opportunity to explore a wide array of specialties within a flexible framework, further developing their clinical and professional skills. Besides the acquisition of specific clinical skills and competencies, core components of BST include personal development such as leadership, team work, communication skills, presentation skills, basic management and audit.

BST is a two-year postgraduate training programme accredited by RCPI. BST is undertaken by Senior House Officers who have completed their internship and wish to specialise in hospital-based medicine.

There are four BST programmes accredited by the RCPI:

1. General Internal Medicine
2. Histopathology
3. Obstetrics & Gynaecology
4. Paediatrics

Completion of BST is a requirement for entry into the Registrar Training Programme (RTP) and Higher Specialist Training (HST) in most specialties.

BST consists of two educational elements:

1. Two years of supervised clinical training in approved SHO posts, during which certain skills must be acquired. These skills are listed in the relevant BST curriculum, available only to registered trainees.
2. Several educational courses, depending on the specialty. Registered trainees are also required to complete BST Logbooks as a record of their progress through the two-year programme.

Entry Requirements:

- Registration with the Medical Council of Ireland on the Trainee division of the Register.
- Completion of internship/pre-registration year (this normally cannot be done in Ireland if your medical school was overseas).

Mandatory Courses:

Please note that all mandatory courses must be completed within the two years of BST. Failure to complete these courses within the two years could affect certification of BST completion.

Bookings for all mandatory courses must be done by completing the relevant application form. No bookings for mandatory courses will be taken via telephone. Application forms are available from the website and must be submitted prior to the course date to secure a place on the course.

Confirmation of application and any further correspondence relating to BST mandatory courses will be sent to your @physicians email address only. No other email address is acceptable. If you experience difficulties with your physicians email address please email reform@rcpi.ie or telephone 01 863 9721 for assistance.

Please note that if you have booked on a course and are unable to attend you must cancel within 10 working days prior to the course start date.

BST Mandatory Courses

The following courses are mandatory for all Trainees registered in BST. There is no fee to attend these programmes if you are registered in BST.

Basic Practical Skills

This is a three-day mandatory course for all Trainees registered in Obstetrics & Gynaecology BST. The objective of the course is to improve Trainees' surgical competencies. This is a teaching programme of basic surgical skills including general surgical and obstetric techniques.

Child Protection

This is one-day mandatory course for all Trainees registered in Paediatrics BST. The course is based on simulated clinical scenarios that encourage active, hands-on participation through learning stations where participants will practice essential skills individually, as part of a team, and as a team leader. Realistic simulations reinforce recognising child abuse and neglect, patterns of injury, what to do, role plays, working together with other professionals and parents and communication.

Ethics, Prescribing Skills and Blood Transfusion

This course is mandatory for all Trainees registered in BST (Histopathology BST Trainees are required to complete Ethics only). It consists of online modules on healthcare ethics, safe prescribing skills and blood transfusion that are prerequisite to a one-day practical workshop where case studies are examined and discussed. The course is divided into specialty specific dates.

* Please note: All the online components need to be completed prior to the workshop. They do not have to be completed consecutively.

BST Mandatory Courses

Family Planning

This is a half-day mandatory course for all Trainees registered in Obstetrics & Gynaecology BST. The course is designed for BST trainees to improve their competencies in the safe and effective use of medications within the areas of family planning.

Professional Development Programme

This course is mandatory for all Trainees registered in BST. It consists of online modules which cover patient safety and teaching skills. Ultrasound

This course is mandatory for Trainees registered in Obstetrics and Gynaecology BST. The course is made up of online modules and workplace based assessments.

Topics include early pregnancy ultrasound, biophysical score, fetal biometry and placental site, and ultrasound of the adnexa. For each of the modules participants are required to complete the online section, a series of corresponding

Objective Structured Assessments for Technical Skills (OSATS) and then record a number of cases.

Registrar Training Programme

The Registrar Training Programme (RTP) is aimed at doctors who wish to progress their career in specialist medical training.

Most doctors who successfully complete Basic Specialist Training (BST) want to enter Higher Specialist Training (HST) at the earliest opportunity. Entry into HST is highly competitive and applicants must have successfully completed their membership examinations. While it is possible for a doctor to progress to HST directly from BST, the majority of doctors require an additional period of training and experience in their chosen specialty. This will usually be achieved by time spent working in a registrar post.

The RTP has been introduced to provide a structured programme of training and formal competence assessment for doctors working in the registrar grade.

Application for entry on to the programme is by competitive interview. Partial credit for this programme may be applied to HST. Doctors who wish to apply for the RTP must complete an application form which will be available on the RCPI website www.rcpi.ie during recruitment.

Training is available in the following specialties:

- General Medicine: including Cardiology, Dermatology, Endocrinology and Diabetes Mellitus, Gastroenterology, Geriatric Medicine, Genito-Urinary Medicine, Infectious Diseases, Nephrology, Neurology, Medical Oncology, Palliative Medicine, Rehabilitation Medicine, Respiratory Medicine, and Rheumatology
- Pathology: including Chemical Pathology, Clinical Microbiology, Haematology, Histopathology and Immunology
- Paediatrics
- Obstetrics and Gynaecology

RTP consists of two educational elements:

1. Supervised clinical training in approved Registrar posts, during which certain skills must be acquired.
2. Several educational courses and completion of RTP Logbooks as a record of their progress through the programme.

Entry requirements:

- Applicants must hold a certificate of completion of BST
- Applicants must not have spent more than 2 years in NCHD posts following completion of BST
- Applicants must be eligible for inclusion on the General or Trainee Specialist Division of the Medical Council's register

Mandatory Courses:

Please note that all mandatory courses must be completed while on the RTP. Failure to complete these courses could affect certification of RTP completion. Bookings for all mandatory courses must be done by completing the relevant application form. No bookings for mandatory courses will be taken via telephone. Application forms are available from the website and must be submitted prior to the course date to secure a place on the course.

Confirmation of application and any further correspondence relating to RTP mandatory courses will be sent to your @physicians email address only. No other email address is acceptable. If you experience difficulties with your physicians email please email reform@rcpi.ie or telephone 01 863 9721 for assistance. Please note that if you have booked on a course and are unable to attend you must cancel within 10 working days prior to the course start date.

RTP Mandatory Courses

The following courses are mandatory for all Trainees registered in RTP. There is no fee to attend these programmes if you are registered in RTP.

Introduction to Clinical Audit

This is a half-day mandatory course for Trainees registered in RTP.

Topics to be discussed include rationale for engaging in clinical audit, direct and indirect benefits to medical practice, professional competence scheme, standards and criteria in measurement, data protection and confidentiality, the crossover between research, clinical audit and service evaluations, how to write and evaluate a clinical audit report, challenges in closing the clinical audit loop and implementing practice improvements.

Higher Specialist Training

The aim of Higher Specialist Training (HST) is to produce doctors who are clinically excellent leaders in their fields and capable of handling the challenges that are faced by those in our health service every day.

On completion of HST, doctors are eligible to register with the Medical Council of Ireland as a medical specialist in their field and to apply for appointment to consultant posts.

Application for entry onto the training programme is by competitive interview. Applications for General Internal Medicine (GIM) open in October. Applications for all other specialties open in November. Application forms can be downloaded online at www.rcpi.ie once the recruitment process has begun.

HST in Ireland is conducted in the grade of Specialist Registrar (SpR). Within the College, the Medical Training Department oversees the training of doctors to specialist level in twenty-five specialties under the governance of six approved training bodies. The training bodies, in conjunction with the Medical Training Department, have developed curricula and approved training posts capable of furnishing all the training experiences necessary for SpRs.

The supervision and day-to-day administration of the training process is carried out by the Dean of Higher Specialist Training and the RCPI Medical Training Department.

The six training bodies in RCPI include:

- Irish Committee on Higher Medical Training, RCPI (ICHMT)
- Institute of Obstetricians & Gynaecologists, RCPI
- Faculty of Occupational Medicine, RCPI
- Faculty of Paediatrics, RCPI
- Faculty of Pathology, RCPI
- Faculty of Public Health Medicine, RCPI

HST consists of two educational elements:

1. 4 – 6 years of supervised clinical training in approved SpR posts, during which certain skills must be acquired. These skills are listed in the relevant HST curriculum.
2. Several educational courses, depending on the specialty. Registered trainees are also required to complete HST Logbooks as a record of their progress through the programme.

Entry Requirements:

- Registration with the Medical Council of Ireland on the Trainee Specialist Division of the Register
- For the majority of specialties, completion of BST and MRCPI or MRCP (UK) is also required. The exceptions to this are Histopathology, Obstetrics & Gynaecology, Occupational Medicine, Palliative Medicine and Public Health Medicine. The entry requirements for these are listed in the relevant HST curriculum.

Mandatory Courses:

Please note that all mandatory courses must be completed within the HST. Failure to complete these courses could affect certification of HST completion. Bookings for all mandatory courses must be done by completing the relevant application form. No bookings for mandatory courses will be taken via telephone. Application forms are available from the website and must be submitted prior to the course date to secure a place on the course.

HST Mandatory Courses

The following courses are mandatory for all Trainees registered in HST. There is no fee to attend these programmes if you are registered in HST.

Core Pathology Skills

This course is mandatory for Trainees registered in all Pathology HST subspecialties. Trainees must complete all three modules during HST. They do not have to be completed consecutively. The course aims to provide the skills for laboratory management.

Module 1: Laboratory Organisation

This one-day module is an introduction to laboratory organisation and covers legal/ethical issues, laboratory testing cycle, laboratory administration, management and design and risk management.

Module 2: Human Resources and Financial & Information Management

This one-day module covers staffing and HR procedures, financial management, health and safety, laboratory automation, clinical laboratory informatics, and education & research in Pathology.

Module 3: Pathology, Organisation and Quality Management

This one-day module covers histopathology and cytopathology, chemical pathology, immunology, medical microbiology, haematology and blood transfusion, laboratory automation, quality assurance, lean six sigma and the clinical laboratory.

Delivering Thrombolysis in a Clinical Practice

HST Mandatory Courses

Endoscopy Programme

This programme is mandatory for Trainees registered in Gastroenterology HST from July 2011. To register for training, Trainees will be registered with the Conjoint Board of RCPI and RCSI at the commencement of training. Please contact your HST specialty administrator for further details.

On entry to the programme, Trainees will be required to attend a simulator course. All Trainees must attend a basic endoscopy course in year one and a hands-on colonoscopy course in later stages of training.

1. Endoscopy Simulator Course

This course is mandatory for Trainees registered in Gastroenterology HST who elect to be enrolled on the endoscopy training programme, and must be completed in the first three months.

2. Basic Skills of GI Endoscopy

This course is mandatory for Trainees registered in Gastroenterology HST who elect to be enrolled on the endoscopy training programme. This

course is an introduction to diagnostic and therapeutic endoscopy.

3. Hands-on Colonoscopy

This course is mandatory for Trainees registered in Gastroenterology HST 2nd year and upwards. The aim of this course is to improve the performance of colonoscopy by providing hands-on training.

HST Mandatory Courses

Ethics

This is a mandatory course for Trainees registered in HST. There are four ethics modules within HST which Trainees are required to complete over the period of their training. They do not have to be completed consecutively. The first three modules are aimed at all specialties and the fourth module is specialty specific.

1. Ethics I: Professionalism

This one-day module will cover professional issues arising from medical practice in the Irish Healthcare System.

2. Ethics II: Ethics and Law

This one-day module will cover ethical and legal issues arising from medical practice in the Irish Healthcare System.

3. Ethics III: Research Ethics

This one-day module will cover ethical issues in research which arise in the Irish Healthcare System.

4. Ethics IV: Specialty Specific

a) End of Life Issues for GIM

Diploma in Cerebrovascular & Stroke Medicine

The Diploma in Cerebrovascular & Stroke Medicine is suitable for Trainees in a number of fields, including General Internal Medicine, Geriatrics, Rehabilitation Medicine, Neurology, Clinical Pharmacology, Emergency Medicine and Anaesthesia.

The Diploma may also be beneficial to Trainees in Vascular Surgery and Neurosurgery and General Practitioners with a significant practice in Cerebrovascular Disease.

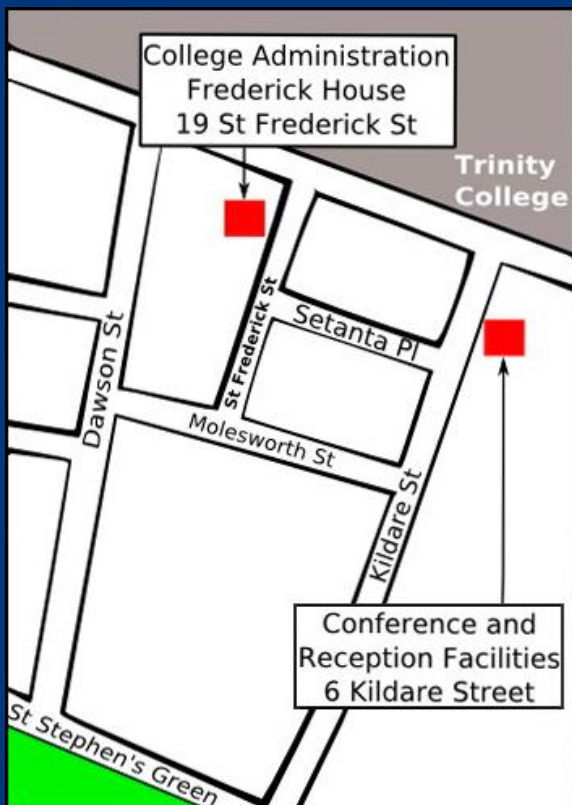
