# Introduction

Nephrology is a predominantly clinical specialty dealing with diseases of the kidneys as they affect people of all ages. Besides the pathophysiological processes involved and the physical impact of each condition, psycho-social effects must also be understood. The potential benefits and risks of specific treatments must be learned and experience gained in the multi-disciplinary approach to management of patients with kidney disease. The physician may later wish to develop subspecialty expertise in areas such as transplantation, obstetric medicine, vasculitis, etc. so it is important that an interest in such topics can be facilitated during training.

Besides these specialty specific elements, trainees in Nephrology must also acquire certain core competencies which are essential for good medical practice. These comprise the generic components of the curriculum.

#### **Aims**

Upon satisfactory completion of specialist training in Nephrology, the doctor will be **competent** to undertake comprehensive medical practice in that specialty in a **professional** manner, unsupervised and independently and/or within a team, in keeping with the needs of the healthcare system.

<u>Competencies</u> at a level consistent with practice in the specialty of Nephrology will include the following:

- Patient care that is appropriate, effective and compassionate dealing with health problems and health promotion.
- Medical knowledge in the basic biomedical, behavioural and clinical sciences, medical ethics and medical jurisprudence and application of such knowledge in patient care.
- Interpersonal and communication skills that ensure effective information exchange with individual patients and their families and teamwork with other health professionals, the scientific community and the public.
- Appraisal and utilisation of new scientific knowledge to update and continuously improve clinical practice.
- The ability to function as a supervisor, trainer and teacher in relation to colleagues, medical students and other health professionals.
- Capability to be a scholar, contributing to development and research in the field of Nephrology.
- Professionalism.
- Knowledge of public health and health policy issues: awareness and responsiveness in the larger context of the health care system, including e.g. the organisation of health care, partnership with health care providers and managers, the practice of cost-effective health care, health economics and resource allocations.
- Ability to understand health care and identify and carry out system-based improvement of care.

#### **Professionalism**

Being a good doctor is more than technical competence. It involves values – putting patients first, safeguarding their interests, being honest, communicating with care and personal attention, and being committed to lifelong learning and continuous improvement. Developing and maintaining values are important; however, it is only through putting values into action that doctors demonstrate the continuing trustworthiness with the public legitimately expect. According to the Medical Council, Good Professional Practice involves the following aspects:

- Effective communication
- · Respect for autonomy and shared decision-making
- Maintaining confidentiality
- Honesty, openness and transparency (especially around mistakes, near-misses and errors)
- · Raising concerns about patient safety
- Maintaining competence and assuring quality of medical practice

# **Entry Requirements**

Applicants for Higher Specialist Training (HST) in Nephrology must have a certificate of completion of Basic Specialist Training (BST) in General Internal Medicine (GIM) and obtained the MRCPI.

Those who do not hold a BST certificate and MRCPI must provide evidence of equivalency.

Entry on the training programme is at year 1. Deferrals are not allowed on entry to Higher Specialist Training.

# **Duration & Organisation of Training**

The duration of HST in Nephrology and GIM is 5 years, at least one year of which must involve high-intensity Nephrology exposure, including dedicated acute Nephrology on-take and acute renal transplantation exposure, and be free of any GIM commitment. One year of the 5 <u>may</u> be gained from a period of full-time research.

While no particular order or sequence of training will be imposed, and programmes offered should be flexible i.e. capable of being adjusted to meet trainees' needs. Trainees must spend the first two years of training in clinical posts in Ireland before undertaking any period of research or Out of Programme Clinical Experience (OCPE). The earlier years of training will usually be directed towards acquiring a broad general experience of Nephrology and GIM under appropriate supervision. An increase in the content of hands-on experience follows naturally, and, as confidence is gained and abilities are acquired, the trainee will be encouraged to assume a greater degree of responsibility and independence.

If an intended career path requires a trainee to develop further an interest in a sub-specialty within Nephrology (e.g. stroke, falls etc.), this should be accommodated as far as possible within the training period, re-adjusting timetables and postings accordingly.

Trainees on HST programme in Nephrology are given a rotation of posts at the start of the programme. Each rotation will provide the trainee with experience in different hospitals so as to acquire the broad range of training required. A degree of flexibility to meet the individuals training needs is possible especially towards the end of the training programme following discussion with the NSDs.

Generic knowledge, skills and attitudes support competencies which are common to good medical practice in all the medical and related specialties. It is intended that all Specialist Registrars (SpRs) should fulfil those competencies during Higher Specialist Training. No time-scale of acquisition is offered, but failure to make progress towards meeting these important objectives <u>at an early stage</u> would cause concern about an SpRs suitability and ability to become independently capable as a specialist.

**Essential Training:** Trainees must attend study days as advised by the National Speciality Director.

All SpRs are expected to take the ASN (American Society of Nephrology) examination in their second year of training and once again before completing the SpR Program. This is organised by your specialty coordinator.

**Minimum Procedures:** Experience should be gained in the practical skills needed for the practice of Nephrology, in particular temporary vascular access for dialysis.

# **Training Programme**

The training programme offered will provide opportunities to fulfil all of the requirements of the curriculum of training for Nephrology and in approved training hospitals. Each post within the programme will have a named trainer/educational supervisor and programmes will be under the direction of the National Specialty Director for Nephrology or, in the case of GIM, the National Specialty Director for GIM or the Regional Specialty Advisor. Programmes will be as flexible as possible consistent with curricular requirements, for example to allow the trainee to develop a subspecialty interest.

The experience gained through rotation around different departments is recognised as an essential part of HST. An SpR may <u>not</u> remain in the same unit for longer than 2 years of clinical training; or with the same trainer for more than 1 year.

Where an essential element of the curriculum is missing from a programme, access to it should be arranged, by day release for example, or if necessary, by secondment.

# **Dual Specialty Training**

GIM training is expected to be completed in the first 3 years of the programme. One of these years is a GIM specific year. During the other 2 years trainees must complete their GIM training as per the minimum requirements alongside Nehrology training.

Each post must include general medicine on-call commitment for acute unscheduled/emergency care with attendance at relevant post-take rounds.

#### **Acute Medicine:**

There must be evidence of direct supervision of the activity of the more junior members of the "ontake" team and a minimum of 10 (480 per year) new acute medical assessments and admissions during the 24-hour period are expected. In addition, the trainee will be expected to have ongoing care/responsibility for a proportion of the patients for the duration of the clinical inpatient journey as well as follow up post discharge. In this capacity you should develop skills in non-technical aspects of care including discharge planning and end of life care.

#### Inpatient Responsibilities:

The trainee will have front line supervisory responsibilities for general medical inpatients only in their GIM specific year but will also supervise Nephrology inpatients in the other 2 years. This will require supervising the activities (e.g. being available for advice) of the more junior members (SHO/Intern) of the clinical team at all times. In addition to personal ward rounds, a minimum of two ward rounds with the consultant each week is expected for educational experience. Ongoing responsibility for shared care of the team's inpatients whilst in the ITU/HDU/CCU is also essential. If this is not possible in a particular hospital/training institution, then a period of secondment to the appropriate unit will be required.

#### **Outpatient Responsibilities:**

The trainee is expected to have personal responsibilities for the assessment and review of general medicine and Nephrology outpatients with a minimum of at least one consultant led clinic per week. The trainee should assess new patients; access to consultant opinion/supervision during the clinic is essential. In the event of clinics being predominantly subspecialty orientated, a trainee must attend other clinics to ensure comprehensive GIM training. During low intensity GIM years, trainees will also be expected to manage haemodialysis, peritoneal dialysis and transplant patients.

# **General Education in Training:**

The trainee is expected to spend four hours per week, in formal general professional education for certification of training. In the types of experience noted below, time must be fairly distributed between GIM and the other specialty in dual training programmes. Review of all these activities will form part of the training record for each trainee.

All trainees are required to undergo training in management. This will take the form of day-to-day involvement in the administration of the team/firm and must include attendance at a management course during the training period.

Trainees are expected to be actively involved in audit throughout their training and should have experience of running the unit's audit programme and presenting results of projects at audit meetings. They should also regularly attend other activities, journal clubs, X-ray conferences, pathology meetings etc.

Trainees should be expected to show evidence of the development of effective communication skills. This can be assessed from taking part in formal case presentations or in giving lectures/seminars to other staff or research/audit presentations at unit meetings.

All trainees must have a current ACLS certificate throughout their HST.

#### **Procedures:**

During training the trainee should acquire those practical skills that are needed in the management of medical emergencies, particularly those occurring out of normal working hours. Some exposure to these skills may have occurred during the period of BST but experience must be consolidated, and competencies reviewed during HST. The procedures, with which the trainee must be familiar and show competencies in, either as <u>essential</u> to acquire, or as <u>additional</u> procedural skills i.e. desirable to acquire.

#### **Essential & Additional Experience:**

The trainee will be expected to have had experience of/be familiar with the management of a wide range of cases presenting to hospitals as part of an unselected acute medical emergency "take". Whilst trainees will not need to be expert in all of these areas they will be expected to be able to plan and interpret the results of immediate investigations, initiate emergency therapy and triage cases to the appropriate specialist care. These emergency situations have been considered under each specialty section and are indicative of what should be covered but are not prescriptive. It should form the basis of regular discussions between the trainee and trainers as training progresses. The various clinical situations listed for experience have been divided into those, which are considered "essential" and others, which are "additional".

# **Assessment Process**

The methods used to assess progress through training must be valid and reliable. The curriculum has been re-written, describing the levels of competence which can be recognised. The assessment grade will be awarded on the basis of direct observation in the workplace by consultant supervisors. Time should be set aside for appraisal following the assessment e.g. of clinical presentations, case management, observation of procedures. As progress is being made, the lower levels of competence will be replaced progressively by those that are higher. Where the grade for an item is judged to be deficient for the stage of training, the assessment should be supported by a detailed note which can later be referred to at the annual evaluation meeting.

The assessment of training may utilise the Clinical Evaluation Exercise (Mini-CEX), Direct Observation of Proceedural Skills (DOPS) and Case Based Discussions (CBD) methods adapted for the purpose. They are offered as a means of providing the trainee with attested evidence of achievement in certain areas of the curriculum e.g. competence in procedural skills, or in generic components. Assessment will also be supported by the trainee's portfolio of achievements and performance at relevant meetings, presentations, audit, in tests of knowledge, attendance at courses and educational events.

# Teaching, Research & Audit

All trainees are required to participate in teaching. They should also receive basic training in research methods, including statistics, so as to be capable of critically evaluating published work. Some trainees may wish to spend two or three years in research leading to an MSc, MD, or PhD, by stepping aside from the programme for a time. For those intending to pursue an academic path, an

extended period of research may be necessary in order to explore a topic fully or to take up an opportunity of developing the basis of a future career. Such extended research may continue after the CSCST is gained. However, those who wish to engage in clinical medical practice must be aware of the need to maintain their clinical skills during any prolonged period concentrated on a research topic, if the need to re-skill is to be avoided.

Trainees are required to engage in audit during training and to provide evidence of having completed the process.

#### **ePortfolio**

The trainee is required to keep their ePortfolio up to date and maintained throughout HST. The ePortfolio will be countersigned as appropriate by the trainers to confirm the satisfactory fulfilment of the required training experience and the acquisition of the competencies set out in the curriculum. This will remain the property of the trainee and must be produced at the annual evaluation meeting. The trainee also has a duty to maximise opportunities to learn, supplementing the training offered with additional self-directed learning in order to fulfil all the educational goals of the curriculum. Trainees must co-operate with other stakeholders in the training process. It is in a SpR's own interest to maintain contact with the Medical Training Department and Dean of Postgraduate Specialist Training, and to respond promptly to all correspondence relating to training. "Failure to co-operate" will be regarded as, in effect, withdrawal from the HST's supervision of training.

At the annual evaluation, the ePortfolio will be examined. The results of any assessments and reports by educational supervisors, together with other material capable of confirming the trainee's achievements, will be reviewed.

# **Generic Components**

This chapter covers the generic components which are relevant to HST trainees of all specialties but with varying degrees of relevance and appropriateness, depending on the specialty. As such, this chapter needs to be viewed as an appropriate guide of the level of knowledge and skills required from all HST trainees with differing application levels in practice.

#### **Good Professional Practice**

**Objective:** Trainees must appreciate that medical professionalism is a core element of being a good doctor and that good medical practice is based on a relationship of trust between the profession and society, in which doctors are expected to meet the highest standards of professional practice and behaviour.

**Medical Council Domains of Good Professional Practice:** Relating to Patients, Communication and Interpersonal Skills, Professionalism, Patient Safety and Quality of Patient Care.

#### **KNOWLEDGE**

#### **Effective Communication**

- How to listen to patients and colleagues
- The principles of open disclosure
- Knowledge and understanding of valid consent
- Teamwork
- · Continuity of care

#### **Ethics**

- Respect for autonomy and shared decision making
- How to enable patients to make their own decisions about their health care
- How to place the patient at the centre of care
- How to protect and properly use sensitive and private patient information in accordance with data protection legislation and how to maintain confidentiality
- The judicious sharing of information with other healthcare professionals where necessary for care following Medical Council Guidelines
- Maintaining competence and assuring quality of medical practice
- How to work within ethical and legal guideline when providing clinical care, carrying research and dealing with end of life issues

#### Honesty, openness and transparency (mistakes and near misses)

- Preventing and managing near misses and adverse events.
- When and how to report a near miss or adverse event
- Incident reporting; root cause and system analysis
- Understanding and learning from errors
- Understanding and managing clinical risk
- Managing complaints
- Following open disclosure practices
- Knowledge of national policy and National Guidelines on Open Disclosure

#### Raising concerns about patient safety

- Safe working practice, role of procedures and protocols in optimal practice
- The importance of standardising practice through the use of checklists, and being vigilant
- Safe healthcare systems and provision of a safe working environment
- Awareness of the multiple factors involved in failures
- Knowledge and understanding of Reason's Swiss cheese model
- Understanding how and why systems break down and why errors are made
- Health care errors and system failures
- Human and economic costs in system failures
- The important of informing a person of authority of systems or service structures that may lead to unsafe practices which may put patients, yourself or other colleagues at risk
- Awareness of the Irish Medical Councils policy on raising concerns about safety in the environment in which you work

#### **SKILLS**

- Effective communication with patients, families and colleagues
- Co-operation and collaboration with colleagues to achieve safe and effective quality patient care
- Being an effective team player
- Ethical and legal decision making skills
- Minimising errors during invasive procedures by developing and adhering to best-practice guidelines for safe surgery
- Minimising medication errors by practicing safe prescribing principles
- Ability to learn from errors and near misses to prevent future errors
- Managing errors and near-misses
- Using relevant information from complaints, incident reports, litigation and quality improvement reports in order to control risks
- Managing complaints
- Using the Open Disclosure Process Algorithm

- Consultant feedback at annual assessment
- Workplace based assessment e.g. Mini-CEX, DOPS, CBD
- Educational supervisor's reports on observed performance (in the workplace): prioritisation of patient safety in practice

#### **Infection Control**

**Objective:** To be able to appropriately manage infections and risk factors for infection at an institutional level, including the prevention of cross-infections and hospital acquired infection

**Medical Council Domains of Good Professional Practice:** Patient Safety and Quality of Patient Care; Management (including Self-Management).

#### **KNOWLEDGE**

#### Within a consultation

- The principles of infection control as defined by the HIQA
- How to minimise the risk of cross-infection during a patient encounter by adhering to best practice guidelines available, including the 5 Moments for Hand Hygiene guidelines
- The principles of preventing infection in high risk groups e.g. managing antibiotic use to prevent Clostridium difficile
- Knowledge and understanding of the local antibiotic prescribing policy
- · Awareness of infections of concern, e.g. MRSA, Clostridium difficile
- Best practice in isolation precautions
- · When and how to notify relevant authorities in the case of notifiable infectious disease
- Understanding the increased risk of infection to patients in surgery or during an invasive procedure and adhering to guidelines for minimising infection in such cases
- The guidelines for needle-stick injury prevention and management

#### **During an outbreak**

- Guidelines for minimising infection in the wider community in cases of communicable diseases and how to seek expert opinion or guidance from infection control specialists where necessary
- Hospital policy/seeking guidance from occupational health professional regarding the need to stay off work/restrict duties when experiencing infections the onward transmission of which might impact on the health of others

## **SKILLS**

- Practicing aseptic techniques and hand hygiene
- · Following local and national guidelines for infection control and management
- Prescribing antibiotics according to antibiotic guidelines
- Encouraging staff, patients and relatives to observe infection control principles
- Communicating effectively with patients regarding treatment and measures recommended to prevent re-infection or spread
- Collaborating with infection control colleagues to manage more complex or uncommon types
  of infection including those requiring isolation e.g. transplant cases, immunocompromised
  host
- In the case of infectious diseases requiring disclosure:
  - Working knowledge of those infections requiring notification
  - Undertaking notification promptly
  - Collaborating with external agencies regarding reporting, investigating and management of notifiable diseases
  - Enlisting / requiring patients' involvement in solving their health problems, providing information and education
  - Utilising and valuing contributions of health education and disease prevention and infection control to health in a community

- Consultant feedback at annual assessment
- Workplace based assessment e.g. Mini-CEX, DOPS, CBD
- Educational supervisor's reports on observed performance (in the workplace): practicing
  aseptic techniques as appropriate to the case and setting, investigating and managing
  infection, prescribing antibiotics according to guidelines
- Completion of infection control induction in the workplace
- Personal Protective Equipment Training Course (In hospital)

# **Self-Care and Maintaining Well-Being**

#### **Objectives:**

- 1. To ensure that trainees understand how their personal histories and current personal lives, as well as their values, attitudes, and biases affect their care of patients so that they can use their emotional responses in patient care to their patients' benefit
- 2. To ensure that trainees care for themselves physically and emotionally, and seek opportunities for enhancing their self-awareness and personal growth

**Medical Council Domains of Good Professional Practice:** Patient Safety and Quality of Patient Care, Relating to Patients, Communication and Interpersonal Skills, Collaboration and Teamwork, Management (including self-management).

#### **KNOWLEDGE**

- Self-awareness including preferences and biases
- Personal psychological strengths and limitations
- Understand how personality characteristics, such as need for approval, judgemental tendencies, needs for perfection and control etc., affect relationships with patients and others
- Knowledge of core beliefs, ideals, and personal philosophies of life, and how these relate to own goals in medicine
- Know how family-of-origin, race, class, religion and gender issues have shaped own attitudes and abilities to discuss these issues with patients
- Understand the difference between feelings of sympathy and feelings of empathy
- Know the factors between a doctor and patient that enhance or interfere with abilities to experience and convey empathy
- Understanding of own attitudes toward uncertainty and risk taking and own need for reassurance
- How own relationships with certain patients can reflect attitudes toward paternalism, autonomy, benevolence, non-malfeasance and justice
- Recognise own feelings in straightforward and complex patient-doctor interactions
- Recognising the symptoms of stress and burn out

#### **SKILLS**

- Exhibiting empathy and showing consideration for all patients, their impairments and attitudes irrespective of cultural and other differences
- Ability to create boundaries with patients that allow for therapeutic alliance
- Challenge authority appropriately from a firm sense of own values and integrity and respond appropriately to situations that involve abuse, unethical behaviour and coercion
- Recognise own limits and seek appropriate support and consultation
- Work collaboratively and effectively with colleagues and other members of health care teams
- Manage effectively commitments to work and personal lives, taking the time to nurture important relationship and oneself
- · Ability to recognise when falling behind and adjusting accordingly
- Demonstrating the ability to cope with changing circumstances, variable demand, being prepared to re-prioritise and ask for help
- Utilising a non-judgemental approach to patient's problem
- Recognise the warning signs of emotional ill-health in self and others and be able to ask for appropriate help
- Commitment to lifelong process of developing and fostering self-awareness, personal growth and well being
- Be open to receiving feedback from others as to how attitudes and behaviours are affecting their care of patients and their interactions with others
- Holding realistic expectations of own and of others' performance, time-conscious, punctual
- Valuing the breadth and depth of experience that can be accessed by associating with professional colleagues

- On-going supervision
- RCPI Ethics programmes
- Wellness Matters Course
- RCPI HST Leadership in Clinical Practice course

#### **Communication in Clinical and Professional Setting**

**Objective:** To demonstrate the ability to communicate effectively and sensitively with patients, their relatives, carers and with professional colleagues in different situations.

**Medical Council Domains of Good Professional Practice:** Relating to Patients; Communication and Interpersonal Skills.

#### **KNOWLEDGE**

#### Within a consultation

- How to effectively listen and attend to patients
- How to structure an interview to obtain/convey information; identify concerns, expectations and priorities; promote understanding, reach conclusions; use appropriate language.
- How to empower the patient and encourage self-management

#### Difficult circumstances

- Understanding of potential areas for difficulty and awkward situations
- How to negotiate cultural, language barriers, dealing with sensory or psychological and/or intellectual impairments and how to deal with challenging or aggressive behaviour
- Knowing how and when to break bad news
- How to communicate essential information where difficulties exist, how to appropriately utilise the assistance of interpreters, chaperones, and relatives.
- How to deal with anger and frustration in self and others
- Selecting appropriate environment; seeking assistance, making and taking time

#### Dealing with professional colleagues and others

- How to communicate with doctors and other members of the healthcare team
- How to provide a concise, written, verbal, or electronic, problem-orientated statement of facts and opinions
- The legal context of status of records and reports, of data protection confidentiality
- Freedom of Information (FOI) issues
- Understanding of the importance of legible, accessible, records to continuity of care
- Knowing when urgent contact becomes necessary and the appropriate place for verbal, telephone, electronic, or written communication
- · Recognition of roles and skills of other health professionals
- Awareness of own abilities/limitations and when to seek help or give assistance, advice to others; when to delegate responsibility and when to refer

#### Maintaining continuity of care

- Understanding the relevance of continuity of care to outcome, within and between phases of healthcare management
- The importance of completion of tasks and documentation, e.g. before handover to another team, department, specialty, including identifying outstanding issues and uncertainties
- Knowledge of the required attitudes, skills and behaviours which facilitate continuity of care
  including, being available and contactable, alerting others to avoid potential confusion or
  misunderstanding through communications failure

#### Dealing with & Managing Acutely III Patients in Appropriate Specialties

Trainees should be able to recognise the critically ill and immediately assess and resuscitate if necessary, formulate a differential diagnosis, treat and/or refer as appropriate, elect relevant investigations and accurately interpret reports.

## Management of acutely ill patients with medical problems

#### Therapeutics and Safe Prescribing

**Objective:** To progressively develop ability to prescribe, review and monitor appropriate therapeutic interventions relevant to clinical practice in specific specialities including non-pharmacological therapies and preventative care.

- Pharmacology, therapeutics of treatments prescribed, choice of routes of administration, dosing schedules, compliance strategies; the objectives, risks and complications of treatment cost-effectiveness

- Commonly prescribed medications
- Adverse drug reactions to commonly used drugs, including complementary medicines
- Identifying common prescribing hazards

- Drugs requiring therapeutic drug monitoring and interpretation of results
- The effects of age, body size, organ dysfunction and concurrent illness or physiological state e.g. pregnancy on drug distribution and metabolism relevant to own practice
- Recognising the roles of regulatory agencies involved in drug use, monitoring and licensing e.g. IMB, and hospital formulary committees
- Procedure for monitoring, managing and reporting adverse drug reaction
- Effects of medications on patient activities including potential effects on a patient's fitness to drive

- Know the difference between an early and late drug allergy, and drug side-effects

# **General Internal Medicine Section**

**Objective**: On completion of Higher Specialist Training the trainee will be able to identify and treat immediate life threatening causes of common medical presentations, form a differential diagnosis for non-life threatening cases and effectively manage the patient including further investigation and appropriate referral. They will have acquired a broad range of procedural and clinical skills to manage diverse presentations.

#### **Assessment and Learning Methods**

Learning opportunities during HST are through:

- Unselected acute on call
- General Medicine outpatient clinics
- Department education sessions (black box, journal club, tutorials)

# In the Acute setting

During the course of HST the trainee will encounter common acute presentations and demonstrate the following competencies:

- Recognising and assessing urgency
- Stabilising the patient
- Prioritising
  - o Tasks
  - Investigations
- Managing co-existing morbidities
- Making appropriate referrals
- Decision making and appropriate delegation

The presentations listed in this section represent the most common acute presentations and conditions currently seen in Irish hospitals, accounting for over 95% of admissions. It is expected that HST trainees in general internal medicine will have a comprehensive knowledge of, and be able to provide a differential diagnosis for, these conditions.

# **Emergency management**

Recognising and managing emergency cases including:

- Critical electrolyte abnormalities (calcium, sodium, potassium)

#### Skills and Knowledge in the General Medicine Setting

On completion of HST the trainee should know life threatening causes, clinical feature, classifications, investigations and management, including indications for urgent referral, for common general medicine presentations. The following outlines commonly associated features, causes and/or routes of investigation for these presentations, both acutely and for ongoing case management, the trainee is expected to know and the competencies they are expected to demonstrate.

When a patient presents with a general medicine complaint the trainee should demonstrate an ability to:

- Assess their signs and symptoms; formulating a differential diagnosis
  - o Take history as part of an investigation
  - Undertake primary assessment
  - Recognise and assess urgency
  - Undertake secondary assessment
- · Initiate appropriate investigations
  - o Interpret results for common investigations
- Initiate appropriate treatment, including stabilising the patient where necessary
- · Manage co-existing morbidities
- Manage on-going cases including
  - o confirming a diagnosis for those not requiring urgent referral
  - assessing response to initial treatment
  - o recognising signs to escalate management when needed
- Appropriately refer based on:
  - Response to treatment
  - Local guidelines
  - Culture
  - Self-awareness of their own knowledge and ability
  - Services available
- · Provide ongoing management of the case

#### Shortness of breath

When a patient presents with shortness of breath a trainee should demonstrate knowledge of the clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for common causes.

- Life threatening causes of breathlessness
  - Airway Obstruction
  - Acute severe asthma
  - Acute exacerbation of COPD
  - o Pulmonary oedema
  - o Tension pneumothorax
  - Acute presentations of Ischaemic heart disease
  - o Acute severe left ventricular failure
  - Dysrhythmia
  - Pulmonary embolus
  - Cardiac tamponade
  - Metabolic acidosis

## Cough

When a patient presents a cough a trainee should demonstrate knowledge of the clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Common causes of acute cough
  - Viral and Pertussis type cough
  - o Acute bronchitis
  - o Pneumonia
  - o Tuberculosis
  - Lung cancer
  - Understand the relevance of subacute and chronic cough
  - Common causes (Asthma, Upper airway, GORD)
  - o When to refer for assessment of lung cancer
  - o Consideration of Interstitial lung disease

#### **Chest Pain**

When a patient presents with chest pain a trainee should demonstrate knowledge of the clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for common causes.

- Life threatening causes of chest pain
  - Myocardial infarction
  - o Dissecting aortic aneurysm
  - Pulmonary emboli
  - Tension pneumothorax
  - Oesophageal rupture
- Clinical features of:
  - Cardiac chest pain
  - o Chest pain caused by respiratory disease and oesophageal rupture
  - Chest pain caused by gastrointestinal disease
  - Chest wall pain
  - o Functional chest pain

## **Blackout / Collapse / Dizziness**

When a patient blacks out, collapses or presents with dizziness a trainee should demonstrate that they know the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Stroke
  - o Cerebral infarction
  - o Primary intracerebral haemorrhage
  - Subarachnoid haemorrhage
- Syncope
  - Cardiac causes (arrhythmia, cardiogenic shock)
  - Vasovagal syncope
  - Postural hypotension (e.g., drugs, neurocardiac, autonomic)
  - o Localised vascular disease (posterior circulation)
  - o Metabolic causes (e.g., hypoglycaemia)
- Seizures and epilepsy

## Management of the frail older patient in the acute setting

When a frail older patient presents a trainee should demonstrate knowledge of the appropriate approach to assessment, risk factors, appropriate investigations and necessary management, including indications for urgent referral, for this population.

- Understand the broad differential diagnosis and management of complex multi-morbid illness in older patients
- Approach to investigation and management of recurrent Falls
- Non-pharmacological and pharmacological management of behavioural complications of dementia
- Investigation of causes, non-pharmacological and pharmacological management of Delirium
- Polypharmacy and inappropriate prescribing in older patients (e.g. renal dose adjustment)
- Medical management of nursing home residents- identifying aspiration risk
- Palliative care and pain management in the acute setting
- Acute stroke thrombolysis delivery and criteria for referral for intravascular intervention
- Completion of NIHSS stroke scale

## **Abdominal Pain**

When a patient presents with abdominal pain a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Initial assessment of abdominal pain
- Differential Diagnosis:
  - o Intra-abdominal
    - Gastrointestinal
    - Vascular (aneurysm, ischemia)
    - Urological
    - Gynaecological
  - Extraabdominal causes of pain
- Ability to identify and initiate management of life threatening conditions causes of abdominal pain
- Indications for surgical consultation and urgent referral
- Identifying constipation and urinary retention in older patients

#### **Fever**

When a patient presents with fever a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Recognize the symptoms and signs of sepsis
- Identify common causes of fever
  - Infection
  - Non-infectious including PE, Drugs, vasculitis,
- Delivery of initial management of septic patient
- · Knowledge of the choice of empiric and infection targeted antibiotics

## Alcohol and substance dependence or withdrawal

When a patient presents with dependence or withdrawal a trainee should demonstrate that they know the classifications and necessary management, including indications for referral.

- Recognition
- Psychosocial dysfunction
- Autonomic disturbances
- Stress and panic disorders
- Insomnia and sleep disturbance
- Understand the role of psychiatrist and referral to rehabilitation services

## **Falls and Decreased mobility**

When a patient falls or presents with decreased mobility a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- · Common medical and social causes of falls in medical patients
- Complications of falls
  - o Fractures including the neck of the femur
  - Intracranial injury
  - Rib fracture and pneumothorax
  - Loss of mobility and independence

## **Weakness and Paralysis**

When a patient presents with weakness or paralysis a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Stroke/ space occupying lesion
- Spinal cord injury
- Underlying neurological causes: e.g. multiple sclerosis, Guillain-Barre syndrome
- · Infections and disease causing weakness

#### Headache

When a patient presents with headache a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- · Clinical classifications of headache
- · Headache with altered neurological and focal signs
- Headache with features suggestive of raised intracranial pressure
- Headache with papilloedema
- · Headache with fever
- Headache with extracranial signs
- Headache with no abnormal signs
- Drugs and toxins

## Limb Pain and/or Swelling

When a patient presents with limb pain or swelling a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- · As a result of injury
- As a result of an underlying medical condition
  - Undifferentiated inflammatory arthritis

## **Nausea and Vomiting**

When a patient with nausea and vomiting a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Understanding of common causes
  - Abdominal
    - Acute Gastroenteritis
    - PUD
    - Pancreatitis
    - Acute hepatitis
    - Bowel obstruction
  - Central Causes (CNS)
  - Poisoning and Medications
- Management
  - o Identification of underlying cause
  - Control of symptoms
  - Treating dehydration

## Seizure

When a patient presents with seizures a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Causes
  - Unprovoked seizures/epilepsy
  - o Seizures associated with metabolic, toxic and system illness
  - Cerebral hypoxia
  - Seizures associated with drugs and toxic substances
- Management
  - Emergency supportive treatment
  - Anticonvulsant treatment
  - Work up of first presentation with seizure
  - o Understand driving implications for patients with seizures

#### Diarrhoea

When a patient presents with diarrhoea a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Classification
  - Osmotic
  - Secretary
  - Exudative
- Causes
  - o Infectious
  - Inflammatory
  - o Ischemic
  - Malignant
- Complications
- Management
  - Acute management
  - Knowledge of appropriate investigations
  - o Recognition of associated complications
  - Role of antibiotics
  - When to refer to gastroenterology.

## **Delirium/Acute confusion**

When a patient presents with delirium or acute confusion a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Clinical features of acute confused state- differentiating delirium, dementia, depression and psychosis
- · Causes of delirium
- Use of screening instruments for delirium and/or cognitive impairment
- Clinical features of acute delirium
- Clinical features of acute functional psychosis
- Causes of confused state associated with alcohol abuse- delirium tremens, Wernicke's encephalopathy
- Drug induced/related confusion/delirium
- Bacterial meningitis. Viral encephalitis
- · Subarachnoid haemorrhage/ subdural haematoma

#### Social issues

When a patient presents with social issues a trainee should demonstrate knowledge of the appropriate approach to assessment, risk factors, appropriate investigations and necessary management, including indications for urgent referral, for this population.

- Managing medical conditions with an uncooperative patient
- Identifying potential elder abuse
- · Recognising substance abuse
- Basic principles of psychiatry
- Recognising an at risk patient

## **Palpitations**

When a patient presents with palpitations a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Anxiety
- Exercise induced
- In relation to pre-existing conditions including
  - Thyroid disease
  - o Anaemia
  - o Fever
  - Dehydration
  - Low blood sugar
  - o Low blood pressure
  - Resulting from medications or toxins
- Hormonal changes
- After prior myocardial infarct
- Coronary artery disease
- Other heart problems including congestive heart failure, heart valve or heart muscle problems

## **Hepatitis or Jaundice**

When a patient presents with hepatitis or jaundice a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Incubation and prodromal phase
- Virus-specific
- Toxic hepatitis
- Autoimmune
- Acute liver failure

## **Gastrointestinal Bleeding**

When a patient presents with gastrointestinal bleeding a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Understanding of the initial assessment and stabilization of patients with GI bleeding
- Understanding of haemovigilance and blood transfusion protocols
- Upper gastrointestinal bleeding including
  - o Peptic ulcer Disease
  - Gastritis
  - o Esophageal varices
  - o Mallory-Weiss tears
  - Gastrointestinal cancers
  - Inflammation of the gastrointestinal lining from ingested material
- · Lower gastrointestinal bleeding including
  - o Diverticular disease
  - Gastrointestinal cancers
  - Inflammatory bowel disease (IBD)
  - o Infectious diarrhoea
  - o Angiodysplasia
  - o Polyps
  - o Haemorrhoids and anal fissures

## Haemoptysis

When a patient presents with haemoptysis a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Recognition and Management of massive Haemoptysisi
- Common causes of haemoptysis
  - Acute and chronic bronchitis
  - Tuberculosis
  - Lung cancer
  - o Pneumonia
  - o Bronchiectasis
  - o Pulmonary Embolus
  - o Alveolar Haemorrhage (vasculitis)

## Rash

When a patient presents with a rash a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Urticaria
- Anaphylaxis and Angio Oedema
- Erythroderma and exfoliation
- Psoriasis and seborrhaoeic/contact dermatitis
- Purpura and vasculitis
- Blistering eruptions
- Infections and the skin

## **Acute Back Pain**

When a patient presents with acute back pain a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Non-specific acute back pain
- Causes of chronic low back pain
- Neurologic findings in back pain
- · Identifying serious etiologies of back pain e.g.,
  - o Cancer
  - o Fracture
  - o Infection
  - Cauda equina syndrome

## **Poisoning and Drug Overdose**

When a patient presents with poisoning or overdose a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- Diagnostic clues in the assessment of overdoses
- Identification of toxic agent (paracetamol, SSRI, benzodiazepines, opiates, amphetamines, TCAD)
- Immediate management
- Mental health assessment and definitive care

## Hyper-glycaemia

When a patient presents with hyper-gycaemia a trainee should demonstrate knowledge of the life threatening causes, clinical feature, classifications, appropriate investigations and necessary management, including indications for urgent referral, for the common causes.

- · Symptoms of acute hyper-glycaemia
- Recognition and Management of diabetic ketoacidosis
- Recognition and management of Hyperosmolar non ketotic hyperglycemic states

- The pathophysiology of sodium, potassium, and hydrogen ion imbalance, and dysregulation of water homeostasis

## Section 3: Acute Kidney Injury and Critical Care Nephrology

## **Evaluation**

**Objective:** To provide the trainee with the skills and knowledge to assess and manage patients with acute kidney injury (AKI) at a specialist level.

- The epidemiology, diagnostic evaluation and pathogenesis of AKI
- The pathophysiology of AKI in different clinical scenarios e.g. acute tubular necrosis, glomerulonephritis, etc.
- Methods available to grade severity of AKI
- Methods of investigation relevant to AKI
- · Medication dosing and safe and effective prescribing for patients with AKI
- Treatment options: renal replacement therapy (including plasma exchange) and treatment relevant to the underlying cause of AKI (including potential adverse effects) such as the management of common AKI syndromes, including:

  - Sepsis-associated AKI
  - Radiocontrast nephropathy

## **SKILLS**

- Taking a history for AKI focusing on drug, social and environmental factors
- Performing a reliable and accurate clinical examination to assess or diagnose AKI and differentiates pre-renal failure, renal failure and urinary tract obstruction
- Ordering, interpreting and acts upon investigations appropriately including: biochemistry, haematology, microbiology, immunology and imaging
- · Performing examinations of the urine sediment for the assessment of AKI
- Performing bedside ultrasound to identify kidney obstruction and kidney size (optional)
- Identifies patients at high risk of AKI and institutes preventative measures
- Initiation of appropriate specialist management of AKI and the underlying cause (including renal replacement therapy, immunosuppression, plasmapheresis etc.)

## **Renal Replacement Therapies in AKI**

- The principles of haemodialysis, haemofiltration and haemodiafiltration and indications for their use
- The options for vascular access for acute renal replacement therapy

Assesses the suitability of a patient for haemodialysis or haemofiltration

 Prescribes haemodialysis and haemofiltration safely, adjusts prescriptions appropriately and monitors response to treatment

- Prescribes medication safely and appropriately in patients with acute kidney injury
- Adjusts dialysis prescription in complex cases e.g. head injury, morbid obesity, acute liver failure, acute poisoning or drug overdose

## **Section 4: Chronic Kidney Disease and Progression**

- The pharmacology of medications in CKD and necessary dose adjustments

- Identify and treats reversible causes of CKD
- Managing the non-renal complications of CKD

- Discussing treatment options with patients appropriately and in liaison with the MDT to support the patient's decision-making processes
- Making timely and appropriate plans for renal replacement therapy where necessary

## Renal Anaemia

- Indications for and the use of erythropoietic stimulating agents (ESAs) and their complications
- Indications for and use of oral and parenteral iron therapy and its complications
- Causes of resistance to ESA therapy and its investigation

## **SKILLS**

- Diagnosing and treating renal anaemia, monitoring the effects of treatment and managing failure of treatment
- Managing renal anaemia in CKD patients not yet on renal replacement therapy
- Managing renal anaemia in CKD patients on renal replacement therapy
- Prescribing and monitoring iron replacement therapy
- Auditing the use of ESAs and iron therapy in individual patients and patient populations

#### Cardiovascular Disease in Patients with CKD

**Objective:** To provide the trainee with the skills and knowledge to assess and treat renal patients with cardiovascular disease

- The impact of cardiovascular disease on morbidity and mortality of patients with renal disease and in those receiving renal replacement therapy
- Cardiovascular risk factors and modification strategies (including hyperlipidaemias and obesity)
- How to manage acute coronary syndromes and associated problems in the renal patient

## **Section 5: Hypertension**

- International guidelines for treatment of HTN
- Unique considerations in treating HTN in special situations such as pregnancy, CKD and diabetes mellitus, and hypertensive urgency/ emergencies
- The importance of non-pharmacological measures in achieving BP targets
- The role of sodium intake in the pathogenesis of HTN
- The assessment and management of pre-eclampsia
- The diagnosis and management of resistant HTN
- The diagnosis and management of hypertensive emergencies

## **SKILLS**

- Assessing a patient with HTN (including use of home and ambulatory BP monitoring) and appropriately investigates to exclude underlying secondary causes
- Identifying the patient with secondary HTN who is suitable for definitive treatment
- Instituting lifestyle measures and a suitable antihypertensive drug regime
- Prescribes antihypertensive medication to achieve blood pressure levels recommended by guidelines
- Monitors and reviews effectiveness of blood pressure control over time with patient and primary care team

- Minimising the risks of AKI after angiographic procedures

- Indications for kidney biopsy in investigation of haematuria, associated risks, likely prognosis and requirement for long term review

- Formulating a differential diagnosis, appropriate plan of investigation and management for a patient with haematuria and / or asymptomatic proteinuria or symptomatic proteinuria or nephrotic syndrome
- Recognising the indications for kidney biopsy in investigation of haematuria and / or proteinuria and discussing the associated risks, likely prognosis and requirement for long term review

- Assessing the severity of proteinuria and the risk of extra-renal complications

  - IgA Nephropathy
- The natural history and prognosis for the primary glomerulonephritides
- The investigation of a patient with glomerulonephritis, both at time of presentation and during long term follow-up (including role of kidney biopsy)
- The available management strategies (both specific and non-specific) including immunosuppression and is aware of recent clinical trials
- The place and timing of renal transplantation

## **SKILLS**

- Clinically assessment of patients with primary glomerulonephritis
- Investigating patients appropriately including laboratory tests, imaging and biopsy
- Interpreting the results of laboratory investigations and kidney biopsy findings
- Making appropriate decisions about urgency of treatment
- Determining the place for immunosuppression, balances risks and benefits, and monitors long term use

## Systemic Diseases with Secondary Glomerular Involvement

- The pathophysiology of systemic disease causing glomerulonephritis especially vasculitis and SLE, viral and other infections and thrombotic microangiopathies
- The various types of secondary glomerulonephritis, aetiology, pathology and clinical manifestations:
  - Lupus Nephritis
  - o Anti-GBM Disease and Goodpasture's Disease
  - Systemic Amyloidosis and Non-amyloid Deposition Diseases
  - o Antineutrophil Cytoplasmic Autoantibodies-Small Vessel Vasculitis
  - Crvoglobulinaemia
  - Scleroderma and thrombotic microangiopathies
- The natural history and prognosis for the different glomerulonephritides
- The investigation of a patient with glomerulonephritis, both at time of presentation and during long term follow-up (including role of kidney biopsy)
- Available management strategies (both specific and non-specific) including immunosuppression and is aware of recent clinical trials
- Recognising the occurrence of rare diseases such as fibrillary GN, scleroderma, cryoglobulinaemia, and knowing where to find more information
- The place and timing of renal transplantation

## SKILLS

- Clinically assessing patients with glomerulonephritis with systemic involvement
- Investigating patients appropriately with laboratory tests, imaging and kidney biopsy
- Interpreting the results of laboratory investigations and kidney biopsy findings
- Making appropriate decisions about urgency of treatment
- Determining the place for immunosuppression, balances risks and benefits, and monitors long term use

## **Tubulointerstitial Nephritis**

## **KNOWLEDGE**

- The pathophysiology of interstitial nephritis and tubulo-interstitial disease, their causes and links with systemic diseases
- Investigations needed in patients with interstitial nephritis
- The natural history and prognosis of interstitial nephritis
- The management strategies for treatment and especially the place for steroids or other immunosuppression

## SKILLS

- Clinically assessing patients with interstitial nephritis, and taking a full drug and environmental history.
- Investigating patients appropriately including use of laboratory tests, imaging and kidney biopsy
- Interpreting the results of appropriate laboratory investigations and kidney biopsy findings
- Making decisions about the urgency of treatment and the place of steroids or other immunesuppression

## Section 8: Renal Disease in Diabetics

**Objective:** To provide the trainee with skills and knowledge to assess and treat patients with diabetes and kidney disease

- Factors that distinguish between diabetic nephropathy and incidental kidney disease in diabetic patients
- The role and importance of lifestyle factors (including smoking), diabetic control and other therapeutic strategies used to manage and slow progression of diabetic nephropathy and in the development of vascular disease
- The indications for referral of diabetic patients to specialist renal clinics
- The differing natural history of patients with diabetic renal disease compared to other CKD patients
- The role of pancreatic and / or renal transplantation in diabetic patients with kidney disease

## **SKILLS**

- Making an accurate and focussed clinical assessment of patients who may have diabetic nephropathy
- Recognising and managing non-diabetic renal disease in the diabetic patient
- Implementing and monitoring treatment for hypertension, hyperlipidaemia and utilising other renoprotective and cardiovascular protective treatments
- Planning the long-term management of the patient with diabetic nephropathy who requires renal replacement therapy including renal transplantation
- Contributing to the management of diabetes and its complications in patients with CKD on dialysis or with a transplant

## **Section 9: Urological Presentations**

## **Kidney Stones**

**Objective:** To provide the trainee with skills and knowledge to assess and investigate a patient with renal stone disease and to formulate a management plan

- The clinical presentation of renal stone disease and its effect on renal function
- How to investigate a patient with renal stones using biochemical and imaging techniques
- Treatment options available including dietary and lifestyle measures to reduce renal stone risk

## **SKILLS**

- Assessing the patient with renal stones and appropriately investigating patients with recurrent renal stones
- Discussing suitable dietary measures to reduce risk of renal stone formation
- Recognising the limitations of medical treatment and appropriately referring patients for surgical assessment
- Recognising the need to appropriately involve other clinicians including dieticians, urologists and radiologists

- The modes of presentation of urinary tract infections (including special circumstances e.g. immunosuppressed or pregnant patients)
- The potential long-term consequences of urinary tract infection

## **SKILLS**

 Investigating and managing all forms of urinary tract infection including recurrent urinary tract infection

## **Urinary Tract Obstruction**

**Objective:** To provide the trainee with skills and knowledge to assess, investigate and manage patients with urinary tract obstruction and neurogenic bladder

- The anatomy of the urinary tract and the common sites and causes of urinary obstruction
- The acute presentation of urinary tract obstruction and the long-term consequences of urinary tract obstruction
- The types of reconstructive procedures undertaken in children and adults and the relevance to future management including transplantation

## SKILLS

- Investigating and managing patients with urinary tract obstruction appropriately (including management of fluid and electrolyte disturbances occurring after the relief of obstruction)
- Recognising when appropriate to involve Radiologists and Urologists
- Explaining to patients and carers the interventions available to patients with urinary tract obstruction and bladder dysfunction (including neurogenic bladder) to avoid infection and prevent progressive renal damage

## Section 10: Inherited and Rare Diseases

**Objective:** To provide the trainee with skills and knowledge to assess, diagnose and treat patients with genetic and other rare diseases and advise on inheritance.

- The pathophysiology and genetics of APKD, Alport's disease, reflux nephropathy, inherited tubular disorders, metabolic disorders such as oxalosis, Fabry's disease and thin membrane nephropathy (amongst others)
- Investigations needed in patients with cystic kidney diseases and other inherited diseases
- The natural history and prognosis of these diseases
- Available treatments and outlines their appropriate use
- The patterns of inheritance of genetic conditions and recognises indications for screening

## **SKILLS**

- Assessing patients with inherited diseases, taking a full history including familial elements, and demonstrating awareness of any extrarenal systemic manifestations
- Initiating investigations including laboratory tests, imaging and kidney biopsy (when appropriate)
- Interpreting the results of investigations and initiating specific treatment appropriately
- Explaining the long term and progressive nature of these diseases to patients and acts to minimise complications
- Determining when screening is required and interpreting results of screening test.

## **Section 11: Special Circumstances**

## **Renal Disorders in Pregnancy**

**Objective:** To provide the trainee with skills and knowledge to counsel patients with pre-existing kidney disease or a renal transplant about sexual health issues including fertility, contraception and the implications of pregnancy.

To also enable trainees to be able to manage renal conditions during pregnancy and to undertake a specialist assessment, investigation and management of a patient who develops a renal disorder during pregnancy.

## **KNOWLEDGE**

- The effects of kidney disease on fertility and the need for safe and effective contraception in patients with renal disease and with a renal transplant
- The effects of pregnancy on renal physiology in normal individuals and those with pre-existing renal disease (including those on renal replacement therapy)
- The potential risks of pregnancy to the mother and foetus in patients with CKD (including dialysis and renal transplant)
- The importance of appropriate drug therapy in pregnancy and potential risks of commonly used drugs to the foetus
- How to manage co-morbid medical conditions in patients with pre-existing renal disease, dialysis or a renal transplant during a pregnancy with particular emphasis on minimisation of the risk to mother and foetus
- To recognise renal disorders that are inherited and the patterns of inheritance

## **SKILLS**

- Counselling patients with renal disease, on dialysis or with a renal transplant about the risks and implications of pregnancy and acting to minimise risks to mother and foetus
- Investigating de-novo renal disease in pregnancy or a deterioration in renal function in a pregnant transplant patient
- Managing hypertension appropriately in pregnancy
- Modification of medication including immunosuppressive drugs appropriately during pregnancy or in a woman planning pregnancy
- Recognising and managing the renal consequences of pre-eclampsia and AKI in pregnancy and the puerperium
- Explaining the inheritance of genetic disorders, recognising the need for genetic counselling and appropriate referral

## Transition of Paediatric Patients to Adult Nephrology Services

- The common causes of CKD in paediatric patients, and where to obtain information on rarer causes of CKD in these patients
- Issues relating to consent and confidentiality in adolescent patients

• The impact of renal disease on other physical systems within the patient, on the psychosocial functioning of the patient, family, carers, and other professionals (healthcare, colleges etc)

 The importance of the developmental stage when communicating with adolescents and young adults

## **SKILLS**

- Making an accurate and focussed clinical assessment of patients with kidney disease at the adult / paediatric interface
- Treating the patient holistically and sensitively in accordance with the patient's wishes and taking account of the needs and wishes of the carers and family members of the patient
- Managing the change of environment within which the patient will be managed
- Managing the change in personnel and referral systems applicable to CKD, dialysis and transplant patients at the paediatric / adult interface
- Recognising when the timing of referral from paediatric / young person / adolescent service to adult renal services is appropriate

- Consideration of a patient's nutritional status and provision of appropriate nutritional advice with the support of dieticians
- · Managing the nutritional needs of patients with AKI and other complex multisystem disorders

- The evidence for active supportive care (non-dialysis) care of CKD
- The principles of pain relief and appropriate analgesic prescription in end stage renal disease (ESRD)
- The factors affecting survival in patients with ESRD
- The clinical features of dying
- The principles of bereavement management
- The medicolegal framework for decisions about patient treatment and advanced directives
- When to initiate a care pathway for dying patients with the help of the multidisciplinary and palliative care teams

## **SKILLS**

- Identification of patients requiring active support management or end of life care
- Counseling patients and carers about active supportive care (conservative or non-dialysis, nontransplant) management of advanced CKD
- Recognition and management of the symptoms of ESRD including prescription of effective analgesia for patients requiring pain relief and initial management of depression
- Identification of the patient who is deteriorating despite dialysis; counselling of patients and carers about withdrawal of dialysis with the support of the multidisciplinary team

- The evidence for treatment targets of haemodialysis adequacy
- The complications of arterio-venous fistulae and artificial grafts
- The management of dialysis line sepsis, poor flow and line blockage
- The pathophysiology and management of intradialytic hypotension

## **SKILLS**

 Prescribing haemodialysis for a patient initiating treatment and adjusting the prescription based on the patient's progress and monitoring

- · Advising on ultrafiltration, sodium profiling and the use of different dialysate solutions
- Discussing the therapeutic and lifestyle implications of home versus hospital-based haemodialysis with a patient and carers
- · Assessing the suitability of different methods of vascular access
- Organising the day-to-day management of a haemodialysis unit
- Identifying and managing the complications of vascular access involving, when necessary, surgeons and radiologists
- Managing dialysis-related sepsis and develops protocols with microbiologists
- Developing protocols to deal with acute dialysis emergencies

- The diagnosis and management of PD associated peritonitis
- The management of the catheter exit site and the prevention, diagnosis and treatment of associated infection
- The diagnosis and management of mechanical problems associated with PD (including herniae, leaks, catheter malfunction)
- The methods used to recognise and manage peritoneal membrane injury, including ultrafiltration failure and encapsulating peritoneal sclerosis

## **SKILLS**

- Assessing the suitability of a patient for PD in the context of other methods of renal replacement therapy
- Adjusting the prescription of PD and monitor change
- Organising the day-to-day management of a PD service
- Adjusting the prescription of PD required following complications
- Managing the prevention and treatment of PD associated infections
- Managing PD technique failure and transfer to haemodialysis

- Assessing the suitability of a person as a living kidney donor
- Developing and carrying out protocols for pre-transplant assessment of recipients and potential living donors

- Recognition of increased risk of cardiovascular and malignant disease in the long term transplant patient and the treatment and preventative strategies available

## **SKILLS**

- Identifying declining transplant function, assesses significance of changes, investigates appropriately, and makes appropriate changes to management
- Utilises strategies that optimise long term graft and patient outcomes
- Identifying and managing cardiovascular, malignant and infectious problems in long-term kidney transplant recipients
- Modifying long term immunosuppressive therapy regimens and tailoring to an individual patient considering other comorbid conditions and changing circumstances
- Minimizing and managing the medical complications of a failing kidney transplant
- Counselling patients and relatives in all aspects of kidney transplantation, including graft failure and preparation for dialysis or re-transplantation

## **Section 14: Procedures**

## **Kidney Biopsy (Native and Transplant)**

**Objective:** To ensure that the trainee knows the indications for and potential complications of a renal transplant biopsy and is familiar with the skills necessary to perform native and transplant kidney biopsy.

## **KNOWLEDGE**

- Indications for a kidney biopsy
- The anatomy of the native and transplant kidneys
- Contraindications to performing a kidney biopsy
- Potential complications of a kidney biopsy

## **SKILLS**

- Minimising and managing the complications of kidney biopsy
- Interpreting the kidney biopsy findings with the assistance of a Histopathologist
- Discussing the indication, perceived benefits and potential risks of the procedure with a patient or relative in a manner that facilitates informed consent
- Discussing biopsy findings with a patient to enable shared decision making regarding treatment options
- Utilising ultrasound to localize kidneys and using ultrasound guidance to assist in kidney biopsy (not mandatory)
- Competent performance of a kidney biopsy (not mandatory)

## **Ultrasound Scanning (Native and Transplant Kidneys)**

**Objective:** The trainee will be proficient at carrying out and interpreting ultrasound scanning of native and transplant kidneys in AKI and to facilitate kidney biopsy. They will also be able to identify anatomy and patency of central veins to facilitate central venous catheter placement.

## **KNOWLEDGE**

- The anatomy of both native and transplant kidneys
- The anatomy of the central veins

## **SKILLS**

- Using ultrasound to localise native and transplant kidneys for the purpose of kidney biopsy
- Localising central veins and assessing their suitability for percutaneous venous access
- Using bedside ultrasound to assess patients with AKI e.g. to rule out obstruction and evaluate kidney cortical thickness

- Study Day
- Recommended: Ultrasound course to include the following:
  - neck and groin veins
  - native kidney
  - o transplant kidney

## Insertion of Temporary Haemodialysis Catheters

**Objective:** To insert and manage temporary haemodialysis catheters.

## **KNOWLEDGE**

- The anatomy of the central venous system in the upper thorax, neck and femoral veins
- Indications for insertion of temporary haemodialysis catheters and the relative merits and problems associated with each site of insertion
- Complications associated with temporary haemodialysis catheter insertion, the methods of minimising these complications and their treatment should they occur
- Treatment of catheter related sepsis and blocked catheters
- Anatomical method of insertion of temporary haemodialysis catheters in all central vein positions

## SKILLS

- Discuss the indications, benefits and adverse events of the procedure to patients, relatives and carers in a manner that will allow informed consent
- Insertion of temporary haemodialysis catheters using the Seldinger technique and ultrasound guidance for bilateral internal jugular and femoral veins
- · Insertion of temporary haemodialysis catheters in all central vein positions
- Explaining the use of the catheter and its management to the patient, relatives and carers

- DOPS
- Insertion of Peritoneal Dialysis Catheters (not mandatory)

**Objective:** The trainee will understand the different methods of inserting PD catheters. The trainee will be proficient at carrying out the insertion of PD catheters by the percutaneous method.

## **KNOWLEDGE**

- Indications for insertion of PD catheters
- Different medical and surgical techniques for insertion of PD catheters including complications and means to minimise these
- Anatomy of the anterior abdominal wall, abdominal cavity and peritoneum, the different types of catheters and their use
- The role of nurses in the management of a catheter after its insertion

## **SKILLS**

- Assessing a patient's suitability for insertion of a PD catheter by different techniques
- Discussing the indications, benefits and adverse events of the procedure to patients, relatives and carers in a manner that will allow informed consent
- Insertion of PD catheters using the percutaneous approach
- Managing acute complications following catheter insertion catheter malposition, catheter related sepsis and occluded catheter
